This year, as in the past, the Oceanside Police Department Crime Prevention Unit will be coordinating the 27th Annual National Night Out. This crime prevention event will be celebrated in cities across the country on Tuesday, August 3, 2010.

National Night out is a special night meant to:

- ✓ **Enhance the relationship between the Community and Police**
- ✓ **Encourage networking and communication between neighbors**
- ✓ **Show that the police and the community are united against crime**
- ✓ **Increase community participation in the neighborhood watch program**

We need your help in order to send a message throughout the City of Oceanside that the Police and the Community stand together against crime. You can help us make this a successful evening by participating within your neighborhood.

The purpose of this letter is to encourage all citizens of Oceanside, including neighborhood HOAs, watch groups and businesses to plan celebrations on **Tuesday, August 3rd**, such as BBQs with their neighbors, ice cream socials, or anti-crime walks through the neighborhood. For those groups who register their event, law enforcement representatives will travel throughout the City to pay them a visit. Additionally, we encourage residents to turn on their porch lights to show support for National Night Out.

In order for police representatives to visit your community event, you should register with Crime Prevention as soon as possible. The sooner you register, the more assistance we can provide for you and your group in planning, event ideas, and flyers.

We need to receive your registration no later than **Tuesday, July 27th 2010**. After that time, your registration is considered late, and you may not have an opportunity to receive a visit from the police. Please schedule your event between the hours of 6:00 pm and 9:00 pm.
